Sir,

With reference to your application on the subject dated above, I am directed to convey the approval of the Director of Education for grant of recognition to your school from class Ist to VIIIth only (without aid) u.e.f. 1991-92 session subject to the fulfillment of the terms and conditions here in mentioned below:-

1. That the management of the school shall abide by all the provisions of Delhi School Education Act & Rules, 1973 and the rules framed thereunder as well as the instructions issued from time to time by the Department.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Inderpuri area.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the Department and in accordance with the provisions of rules 96 of D.S.E. Rules, 1973 and unqualified staff if any shall be replaced by qualified staff.
4. That the school shall strictly abide by the provisions of Delhi School Education Act & Rules, 1973, and payment to all the employees shall be made as per provision of section 10 (thereby making payment of pay and Allowances as are being paid to the teachers in Govt. schools. The payment of salary may be made to the employees by crossed cheques.
5. That the enrolment in each section shall not exceed the number of students calculated @ 12 sq. ft. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Director of Education, Delhi, in each class. Number of the existing sections should not exceed the number of the class rooms of proper size in the schools.

6. That the school shall dispence with the services of unqualified and over-aged staff, if any immediately.
7. That all the conditions under rules 50 and 51 would be fulfilled within one month of the commencement of academic session 1991-92, and provisions of rules 6,7 and 9 be strictly observed.
8. That the arrangement for potable water shall be made available to all the students as well as well teachers and other staff and sanitary facilities shall also be provided to the students adequately.
9. That the service contract between the management and the employees of the school shall be executed immediately and a specimen copy of the same furnished to this office.
10. That the pre-nursery and nursery classes will not run within the premises of Middle school building.
11. That the basement if any in the school should not be used for running classes in any way.
12. That the Society will obtain land from the D.S.A in the name of Society for the construction of un-aided school and shall shift its classes to the new site with the prior permission of the Director of Education will not apply for upgradation in the same premises till the school is shifted to the site/land to be allotted by the D.S.A.
13. That any violation of the provisions of D.S.E.R & R. 1973 and also the instructions/orders/conditions / Rules and Regulations etc. of the Department either in part or incete shall lead to the withdrawal of recognition of the school.

Sir,

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi Admn. Delhi, for the upgradation of the existing Middle School to Secondary level (without aid) with effect from the academic session 1993-94, subject to the fulfillment of the following terms and conditions :-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules, 1973, as well as the instructions issued from time to time by the Department.
2. That the school shall admit the students without any discrimination of caste and creed but keeping in view the admission norms.
3. That the Managing Committee of the school shall also meet the full liability of Secondary classes also alongwith Middle classes and Primary classes.
4. That the school shall appoint full time qualified/ eligible and adequate number of staff for Secondary classes of the school as per provisions of Rule 96 of Delhi School Education Rules, 1973, and also keeping in view the present norms of the Department, and unqualified staff if any shall be replaced by qualified staff immediately.
5. That the school shall strictly abide by the provisions of Section 10 of D.S.E. Act, 1973, thereby paying the scales of pay and allowances, medical facilities, pension, gratuity, provident fund and other prescribed benefits to its employees equal to those of the employees of the corresponding status in schools run by the appropriate authority. The payment of salary shall be made to the employees by crossed cheques.

6. That the enrolment in each section shall not exceed the number of students calculated @ 10 sq.fts. per student for the available floor area of the class room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi, in each class. Number of existing sections should not exceed the number of class rooms of prescribed s-size in the school.
7. That the school shall dispense with the services of unqualified and over-aged staff, if any, immediately.
8. That the conditions under rules 50 and 51 would be fulfilled within one month of the issue of this letter and the provisions of rules 6, 7 and 9 shall be strictly observed.
9. That the pre-nursary and nursery classes will not be run within the premises of school building.
10. That the school shall not run any unrecognized classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only.
11. That the school will follow the syllabus/books prescribed by the Department.
12. That no employee of the school shall be dismissed, removed or reduced in rank nor his/her services be otherwise terminated without the prior permission of the Director of Education, Delhi.
13. That the school shall equip the Science Laboratory with adequate number of Science equipments and apparatus as per the norms of the C.B.S.E. and the Directorate of Education, Delhi Administration, and suitable facilities for practical work shall be provided to the students.
14. That a proper library shall be established and facilities for Reading Room shall also be made available for students and teachers. Books as per ratio of 10 books per student shall be provided to the students.
15. That the management to ensure that it has adequate funds to meet its financial responsibilities for regular payments of salary and all other allowances to its employees through crossed cheques, shall create a Reserve Fund in a nationalised bank equivalent to three months' salary of the staff in the joint names of the Director of Education and the Manager of the school with the specific instructions to the bank that the Director of Education can operate the account individually in case of default in the payment of salaries to the staff.

16. That the building of the school will not be used for any commercial, political, religious or for any other non-educational purposes/activities.

17. That the school shall comply with the norms of the C.B.S.E. and shall apply for its affiliation with the C.B.S.E. for examination purposes.

18. That any violation of the provisions of Delhi School Education Act & Rules, 1973, and also the instructions/orders/conditions etc. of the Department, either in part or in toto shall lead to the withdrawal of recognition/upgradation of the school.

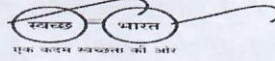
